



## “Revised Recommendations for HIV Screening of Pregnant Women”

This broadcast will discuss *Revised Recommendations for HIV Screening of Pregnant Women* - - published November 9, 2001 in CDC’s Morbidity and Mortality Weekly Report (MMWR) *Recommendations and Reports* series. The agenda includes the key recommendations, revisions from previous guidelines, implementation issues, resources and recommended reading. Viewers may fax in questions before and during the broadcast.

- Objectives:** At the completion of the broadcast, participants should expect to be able to:
- describe key points in “*Revised Recommendations for HIV Screening of Pregnant Women*”
  - identify major revisions from CDC’s previous recommendations on preventing perinatal transmission of HIV
  - identify special populations at high risk for perinatal transmission of HIV and who may be less likely to receive antenatal testing (e.g. adolescents, women who have been incarcerated, and rural antenatal populations)
  - discuss strategies to bridge gaps and barriers in prevention services for pregnant women including in obstetrical practices
  - discuss consumer (client) recommendations for implementing the recommendations
  - identify resources for preventing perinatal transmission of HIV.

**Target Audience:** Health care providers and HIV/STD prevention staff in health departments, community organizations/planning, HIV prevention counseling, education, testing and administration as well as other persons in contact with women of child-bearing age regarding any health matters such as prenatal care, primary care, and substance abuse.

## Instructions for Viewers

Viewers do not need to register with CDC.

**Beginning February 22**, a list of registered viewing sites open to guests will be updated daily on the Broadcast Web Site. After February 22, viewers are strongly encouraged to periodically check the web site to determine if more viewing sites have registered in their area. Viewers without Internet access may call the National Prevention Information Network at 800-458-5231. Persons in search of a viewing site are encouraged to contact a registered viewing site between February 22 and April 18 to request seating.

## Setting up a Viewing Site

Organizations are asked to set up their own viewing sites as soon as possible. To do this, identify and reserve a viewing site with a steerable antenna that receives either C- or Ku-band satellites. Examples of such sites include schools, hospitals, community colleges, universities, and county extension offices. Live calls will not be taken during this broadcast. Locating a fax machine near the viewing room will allow viewers to fax in questions.

## Important Message to Viewing Locations

To ensure satellite reception, we **strongly** encourage:

- training or hiring a technician to operate the satellite equipment for this broadcast, and
- having that person participate in the satellite signal tests **the day before the broadcast and the day of the broadcast**. Participation in both signal tests is especially important if your site experienced a technical problem with a previous satellite broadcast.
